REGULATIONS

1. Field use by permit ONLY. No one but members of said organization should be allowed to use this permit.
2. NO Alcoholic Beverages allowed on Town Property. Police take notice.
3. DO NOT leave trash/debris on Town Property. Carry-In/Carry-Out Policy.
4. NO motorized vehicles of any kind on Town Property.
5. NO golf allowed on Town Property.
6. Please carry this permit with you as proof of your reservation.
7. School teams have priority; you must wait for them to finish regardless of your permit starting time.
8. Groups that violate Fields Committee Regulations may have Permits revoked and may be subject to legal action.
9. The Fields Committee reserves the right to revise these regulations at any time and to rule on situations not specifically covered by these regulations.

INCLEMENT WEATHER

1. A field is automatically closed if standing water is evident.
2. Monday through Friday, the Fields Committee designee reserves the right until 5 pm to close the field. After 5 pm, the decision will be left up to League Officials and/or Officials from the Fields Committee who are on site.
3. Saturday and Sunday, the decision will be left up to League Officials and/or Officials from the Fields Committee who are on site
4. Use of a closed field jeopardizes the safety of all. Future permits will be reconsidered. In addition, if the field requires additional maintenance to restore it to a safe condition, the costs may be charged to the League/Team/Permit Holder.
5. We expect all users to use common sense when it comes to inclement weather.

PRIORITY OF THE USE OF FACILITIES

1. North Andover School Sports Programs
2. North Andover Youth Sports Programs (NASA, NALAX, BOOSTERS CLUB, NABCLL)
3. North Andover Non-Profit Group Programs, civic and religious groups (youth and adult)
4. All other Non-Profit, civic and religious groups
5. For Profit Groups (youth and adult)

USER FEE: Fields are permitted in two-hour blocks. The fee is \$200.00 per two-hour block.
